The present appeal dated Nil received by AA on 26/07/2013 has been preferred by Shri Prakash Fulchand Shah, hereinafter referred to as the Appellant, against the order bearing reference No MRPL/HR/RTI/279/2013-14 dated 12/06/2013 of Shri P A Jose, CPIO, MRPL Mangalore.

Facts:

1. Shri Prakash Fulchand Shah, the applicant vide his application dated 14/05/2013 received by CPIO on 21/05/2013, sought information on Transfer of Physical Shares of MRPL's time period, under the RTI Act, 2005 from the CPIO, Shri P.A Jose, HR Department, MRPL Mangalore.
2. The CPIO, vide his letter bearing reference no MRPL/HR/RTI/279/2013-14 dated 12/06/2013 replied to the applicant, on all the 5 queries.
3. Dissatisfied with the reply given by the CPIO, the Appellant has preferred the present appeal dated Nil.
4. The Appellant, in his appeal dated Nil, has stated, inter alia, the following grounds for preferring the present appeal:
 - Question (1) information given by MRPL not satisfy as per our Enquiry not given by MRPL, the proof of postage department, xerox copy of register delivered to me. In their reply they inform that there was no claim by me. Means your date of reply not necessary. You must send my certificate of MRPL immediately as rejected by you.
 - Question (2) Not send proof of old objection memo, delivered by post department with photocopy.
 - Question (3) List of MD of during period was not sent.
 - Question (4) Not given me status report of said period.

5. The views/comments on the appeal were called for from office of the Company Secretary.


Decision :

1. The appellant in his appeal dated Nil has stated that CPIO has not given satisfactory reply. Based on the review of relevant documents, the decision / direction of the undersigned is as follows:

- a) Question (1) : CPIO has furnished all the information pertaining to transfer of physical shares of MRPL time period vide his letter bearing reference no MRPL/HR/RTI/279/ 2013-14 dated 12/06/2013. Any investor grievance could be settled after following the due process envisaged under 'The Companies Act, / SEBI Regulations. RTI Act should not be invoked for the aforesaid purpose. For any share related grievance the appellant is directed to approach the office of the Company Secretary or the R & T agent M/s Link Intime.
- b) Question (2) As the document is 16 years old, the same has been destroyed by the earlier R & T agent as intimated by the Secretarial Department.
- c) Question (3) The list of Managing Directors was furnished by the CPIO vide his letter bearing reference no MRPL / HR/ RTI/ 279/ 2013-14 dated 12/06/2013. However a copy of the same is furnished again which is appended.
- d) Question(4) The status was provided by the CPIO vide his letter bearing reference no MRPL/HR/RTI/279/2013-14 dated 12/06/2013.

2. The Appeal is disposed of accordingly.

3. A copy of this order be forwarded to the Appellant and the CPIO.
