The present appeal dated December 22, 2011 has been referred by Shri Hanumanth G. Kamath, hereinafter referred to as the appellant, against the reply / decision bearing reference No. MRPL/HR/RTI /84/2011-12 dated November 10, 2011 of Shri P. A. Jose, CPIO, Mangalore Refinery and Petrochemical Limited, Mangalore – 575 030.

**Facts:**

Shri Hanumanth G. Kamath, the applicant, vide application bearing reference No. Nil, dated September 28, 2011, received by CPIO on October 05, 2011, sought following information. Therefore, the CPIO provided the following information on September 22, 2011.

The extract of original application made by the applicant, reply given by the CPIO and thereafter appeal preferred by the appellant are reproduced hereunder:

Copy of the recruitment policy of the Company is attached as Annexure 2 (33 pages).	I had also asked for the copy of the MRPL Recruitment Policy. You have given a copy of the policy which is not authenticated by the sign & seal of the Company.
3.	Order copies of recruitment done at Mangalore Refinery and Petrochemicals Limited from 1 <sup>st</sup> January 2007 to 30 September 2011. (Details: Employee number, Date of joining, Name, Age, Qualification, Experience, training period, Department, Grade, date of test & interview).	List of employees who have joined MRPL from 01.01.2007 till 30.09.2011 is enclosed at Annexure 3 (15 pages).	In the query I had asked for the copy of all the recruitment done at MRPL since 2007 with details such as Name, Age, Qualification, Experience, training period, Department, Grade, Date of joining, Date of test /interview. But was not provided with date of test/interview conducted.

As against the reply furnished by the CPIO, the appellant preferred the present appeal. The appellant in his appeal has informed that the reply is not satisfactory as it is not furnishing all the information required. The appellant, therefore, requested that other information may be furnished to him in the matter. Views/Comments in respect of the appeal were called for from the CPIO.

#### DECISIONS:

1. The information sought by the above referred application as available with this Public Authority was sent. On scrutiny it was observed that information on "Area/land acquired in acres" was not provided – please find the same enclosed as Annexure 'A' (8 pages).
2. In this regard please note that as Appellate Authority of the company, the reply furnished by CPIO on the issue is certified to be an authenticated copy.
3. Details available have been furnished in the available format held by the Company. However the date of test & interview conducted for the same is furnished herewith in the available format, as Annexure 'B' (3 pages).
