Arbitration:	In case of any dispute between the parties for any
	reason whatsoever, the matter shall be referred to
	the sole arbitrator to be appointed by MRPL, whose
	decision shall be final & binding upon the parties.
	The seat and place of arbitration shall be New Delhi
	and language shall be English. Both parties shall
	equally share the cost of arbitration proceedings.
	Parties means the Applicant herein and MRPL.
Governing Law:	All the transactions between the parties shall be
	subject to and governed by Indian Laws. Court at
	Delhi, in exclusion to all other courts, shall have
	exclusive jurisdiction over the matter. Parties means
	the Applicant herein and MRPL.
